SECTION 4: First Aid Measures

EMERGENCY OVERVIEW

SECTION 5: Firefighting Measures

Suitable fire extinguishing media:

Use water spray, fog or foam.

Specific hazards arising from the chemical:

Combustible liquid. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of subsequent explosion. Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion. Runoff to sewer may create fire hazard.

Specific fire-fighting methods:

SECTION 6: Accidental Release Measures

Personal precautions:

Put on appropriate personal protective equipment (see section 8)

Environmental precautions and clean-up methods:

Stop all leaks. Isolate hazard area. Keep unnecessary and unprotected personnel from entering. Eliminate all ignition sources. Disperse vapors with water spray. Prevent runoff from entering drains, sewers, streams or other bodies of water. Absorb spill with inert material. Absorb unrecoverable product. Transfer contaminated absorbent, soil and other materials to containers for disposal.

SECTION 7: Handling and Storage

Do not get in eyes, on skin or on clothing. Avoid breathing sprays and vapors. Avoid skin contact. Keep out of reach of children.

Do not use or store near heat, sparks or open flame. Store in a cool, dry place. Ground/bond container and receiving equipment. Use explosion-proof ventilating and equipment. Use only non-sparking tools. Take precautionary measures against static discharge.
