EMERGENCY OVERVIEW

SECTION 5: Firefighting Measures

Suitable fire extinguishing media:

Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion. Runoff to sewer may create fire hazard.

SECTION 6: Accidental Release Measures

Personal precautions:

Put on appropriate personal protective equipment (see section 8)

Environmental precautions and clean-up methods:
