#### **EMERGENCY OVERVIEW**

## **SECTION 5: Firefighting Measures**

### **SECTION 6: Accidental Release Measures**

#### **Personal precautions:**

#### **Environmental precautions and clean-up methods:**

Stop all leaks. Isolate hazard area. Keep unnecessary and unprotected personnel from entering. Eliminate all ignition sources. Disperse vapors with water spray. Transfer contaminated absorbent, soil and other materials to containers for disposal.
