SECTION 4: First Aid Measures

EMERGENCY OVERVIEW

DANGER. Extremely flammable. Contents under pressure. Harmful or fatal if swallowed. Aspiration hazard if swallowed. Vapor harmful. Specific fire-fighting methods:

Transfer contaminated absorbent, soil and other materials to containers for disposal.
