SECTION 4: First Aid Measures

EMERGENCY OVERVIEW

subsequent explosion. Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion. Bursting aerosol containers may be propelled from a fire at high speed. Runoff to sewer may create fire or explosion hazard.

Specific fire-fighting methods:

SECTION 6: Accidental Release Measures

Transfer contaminated absorbent, soil and other materials to containers for disposal.
