SECTION 4: First Aid Measures

EMERGENCY OVERVIEW

SECTION 5: Firefighting Measures

Suitable fire extinguishing media:

Specific hazards arising from the chemical:

Flammable aerosol. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of subsequent explosion. Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion. Transfer contaminated absorbent, soil and other materials to containers for disposal.
